LEAGUE GUIDELINES

1. All matches consist of 1 game to 25 points. All points scored during the match count toward total team points. In addition, the following bonus points are awarded.

*****BONUS POINTS*****

10 points scored	add 1 bonus point
15 points scored	add 2 bonus points
20 points scored	add 3 bonus points
25 points scored	add 5 bonus points

EXAMPLE:

Match score is Joe Doe 25, Henry Smith 17

Total points for Joe: $25 + 5 = 30$

Total points for Henry: $17 + 2 = 19$

2. To help keep the league running on schedule, please.....
- Check in upon arriving
 - Arrive 10 minutes prior to scheduled playing time
 - Warm-up on squash court prior to playing
3. Players who cannot play a match may choose a substitute of the same or lesser playing ability. Roster players may not act as substitutes. Substitutes may be selected from the attached list or it may be someone you know who isn't on the list. Subs are encouraged to play only 1 match per evening. If you make arrangements for a substitute, please notify one of the league directors, Dorothea Hughes or Jeff Hanno, at 253-5304.
4. Player rankings within a team may be changed if the team captain and league director feel it is warranted and in the best interest of all concerned.
5. All USAR Rules will be followed throughout league play. Each player is allowed two 30-second time-outs during each match.
6. A post league party and awards presentation will be held April 5 , at 7:00pm, at Daut's, E. Genesee St., Auburn. Please join us!
7. Winning players record the match results immediately upon conclusion of the game. A sheet will be provided on the 4th floor of the new courts for this purpose. Please do not add bonus points at this time.
